## Waiver and Release of Liability (2 of 2)



During the current pandemic of Covid-19, I \_\_\_\_\_, agree to let my child \_\_\_\_\_ to participate in the New program provided by Green Grass Learning Center. I am aware of the severity and potential risks posed by the pandemic at this point in time, and take full responsibility to uphold the health requirements of the state, county, and those proposed by Green Grass Learning Center. I will do everything I can and strictly abide by the following requirements of Green Grass Learning Center, as stated below:

1. If I, or my family (including all people living in my house), have or have been in contact with anyone who has been confirmed as a positive case, my child will be withdrawn from all activities of this program.
2. If your child has traveled abroad or out of state in the past 14 days, please register after 14 days of return.
3. If your child is unwell, please let your child stay at home. If your child has any symptom of illness in the center, I will pick up my child from learning center as soon as possible, I also authorize Green Grass Learning Center or their staff to take the necessary actions. Any expense incurred in obtaining such medical care will be paid by me/us.
4. I understand that under the current pandemic, I will allow the Green Grass Learning Center or their staff to use a non-contact forehead thermometer to check the temperature of my child. If there is an abnormal temperature, Green Grass Learning Center has the right to refuse care and remove your child from all activities of the week.
5. Please discuss with your child the proper hygiene requirements under the current pandemic.
  - a. - Always to wear a mask or face shield,
  - b. Maintain a certain social distance with other children.
  - c. If he / she sneezes or coughs, please have he / she cover his / her mouth with a tissue and discard it in the trash can.
  - d. Wash their hands frequently, using soap for at least twenty seconds.
  - e. Use your own drinking glass and do not share food.
  - f. Do not touch eyes, mouth and nose with your hands to prevent germs from invading from these places.

### **Requirements for the use of electronic products,**

In order to help your child continue to attend school courses in Green Grass Learning center, our center is also prepared. We have increased the network speed of the center to 1 gigabyte of downloads and provide high-speed wireless internet.

1. Bring your own electronic products and charging equipment, and label your name.
2. Provide information about the subjects and time of the children's classes, teachers and online classes.
3. If required, parents can formulate your child's computer usage schedule, and we will strictly arrange your child's daily usage according to your schedule
4. Please let your children take good care of their electronic equipment and use their own electronic products safely. The center is not responsible for any damage.
5. I understand that under the current pandemic, in order to avoid excessive contact and cross-contamination, Green Grass Learning Center will no longer mix learning equipment, and individuals will use their own supplies. At the same time, Green Grass Learning Center will take more cleaning methods, such as using disinfectant sprays to clean classrooms, toilets, and

accessible surfaces. I understand and allow Green Grass Learning Center and its employees to use related cleaning items to provide a hygienic and safe environment for my children.

6. I understand that under the current pandemic, Green Grass Learning Center will do their best to provide some sanitary products, such as disinfectant spray, hand sanitizer, masks, face shield, etc. Due to the current shortage of materials, I will do my part and prepare whatever I can myself.
7. I understand that there are many uncertainties, and Green Grass Learning Center will have the right to make all final decisions regarding the program. This includes canceling any potentially hazardous activities and refusing to serve anyone that can be deemed potentially hazardous to the health of the students and employees. Green Grass Learning Center's decisions are based on the safety and health of the majority. I will do my best to meet the requirements of Green Grass Learning Center.
8. I know that the staff of Green Grass Learning Center is also working hard. I will actively cooperate with the staff of Green Grass Learning Center to provide a safe and healthy environment for everyone.

Understand that during the COVID-19 pandemic period, there may be some situations that are unaccounted for, and all accidents that may occur under unpredictable circumstances is not Green Grass's responsibility. ## Declaration
