Class Policy

- Each class will be **no longer than 60 minutes**.
- Students must arrive on time for their assigned class.
 - If a student is **more than 10 minutes late**, the class will be **cancelled**, and **no refund or make-up class** will be provided.
- If you need to **reschedule a class for personal reasons**, a **minimum of one week's notice** is required.
- If, for any reason, **GGLC or the teacher** is unable to provide the scheduled class, we will either **reschedule the class** or issue a **full credit or refund**.

Waiver and Release of Liability
